2024 APPLICATION FORM

The New Zealand Road Safety, Emergency Response and Healthcare Awards are for ordinary people doing exceptional work, day in, day out, across New Zealand.

The Awards are designed specifically for industry professionals in emergency services, hospital care, post hospital care, primary Healthcare, road safety and recognise those in the community who may otherwise not be acknowledged.

BACKGROUND

New Zealand Road Safety, Emergency Response and Healthcare Awards and Medallion was established in 2021 through the nationalisation of the Canterbury Road Trauma Awards. The New Zealand Road Safety, Emergency Response and Healthcare Awards are founded by the Road Traffic Accident Trauma Charitable Trust trading as National Road Trauma Centre.

NATIONAL AWARD FOR EMERGENCY RESPONSE AND HEALTHCARE

The National Award for Emergency Response and Healthcare recognises outstanding individuals, groups or organisations in Healthcare or in emergency services who respond to road trauma for a particularly noteworthy response to either an incidence, or incidences, of road trauma, or deserving of special recognition for their contribution to improved processes of care for road trauma victims. This application form has sections relating to these two categories of the Award.

This Award is open to individuals, groups or organisations in healthcare and emergency services who respond to road crashes and road trauma victims.



The National Award for Emergency Response and Healthcare may be Awarded for:

- 1. PARTICULARLY NOTEWORTHY RESPONSE TO AN INCIDENT, OR INCIDENTS, OF ROAD TRAUMA.**
- 2. CONTRIBUTION TO IMPROVED PROCESSES OF CARE FOR ROAD TRAUMA VICTIMS.**

- Increased patient care capacity or patient care quality.
- Addressed an identified need, enhancing outcomes or improving a product, service, process or system that as a direct result will benefit those in their region or nationally.
- Enhanced or assisted in the further development of a product, service, process or system that as a direct result will benefit those in their region or nationally.
- Developed effective ways that minimises the impacts of disability or death after road trauma locally, regionally or nationally.
- Worked with local, regional or national organisations and bodies to put in place emphasis on patient care and/or improve response time for road crash patients.
- Worked with other local, regional or national organisations or agencies to improve response times.
- Used an application of unique skill or creative imagination to solve problems associated with the response to road trauma and road trauma victims.
- Developed new services for population groups that traditionally struggle to access healthcare.

Each Award recipient receives a medallion and a certificate for their meritorious efforts.



AWARD ENTRY GUIDANCE

In preparing an application, the Committee requires a detailed account of the Applicant's contribution, particularly addressing how their service could be considered extraordinary.

- To prepare your entry submission, please ensure you have referred to the New Zealand Road Safety, Emergency Response and Healthcare Awards Criteria, Nomination and Evaluation Process.
- Complete all contact details at the beginning of the Application Form.
- Complete Assessment Criteria A, B or C and note that a 500 word limit applies (in total).
- Links to multimedia may also be included in the submission or submission attachments.
- Letters of management support for the National Award for Healthcare and Emergency Response are **compulsory**. For further information or guidance, please review the Frequently Asked Questions Guide or please contact the Awards Secretariat for further guidance.
- Submissions for the 2024 Awards will be accepted from **9:00am, 19 August 2024 until 11:59pm on 15 September 2024**.
- Please note, due to the timeframes permitted to review nominations, no late submissions will be accepted.

The New Zealand Road Safety, Emergency Response and Healthcare Awards have an agreement with the New Zealand Honours Unit, Cabinet Office, that any significant or deserving nomination deemed by the Committee to meet the criteria for recognition by the New Zealand Royal Honours System, including the New Zealand Government Bravery Awards, the Applicant will be notified by the Committee by way of letter.

The formal decision to proceed with an Award nomination or withdraw the application, to instead nominate for a New Zealand Royal Honour, will be made by the applicant.

Upon receipt, applications are collated and prepared by the New Zealand Road Safety Emergency Response and Healthcare Awards Secretariat for presentation to the Executive Committee.

All nominations are strictly confidential and the information provided will be used only to assist the Executive Committee in considering the merits of the nomination. The New Zealand Road Safety, Emergency Response and Healthcare Awards Executive Committee and Awards Secretariat keeps all nominations confidential to respect privacy. We ask for the cooperation of nominators and others involved in respecting this policy.

Your application can be about large or small projects, but most notably you will need to demonstrate how the work you are doing is improving outcomes to reduce road trauma and its direct impacts either locally, regionally or nationally in New Zealand.

To be competitive your application must address the following criteria, and provide evidence that substantiates its claims. The criteria used to assess and judge the submissions are common practice for Awards of such caliber.
