The New Zealand Road Safety, Emergency Response and Healthcare Awards are for ordinary people doing exceptional work, day in, day out, across New Zealand.

The Awards are designed specifically for industry professionals in emergency services, hospital care, post hospital care, primary Healthcare, road safety and recognise those in the community who may otherwise not be acknowledged.

## **BACKGROUND**

New Zealand Road Safety, Emergency Response and Healthcare Awards and Medallion was established in 2021 through the nationalisation of the Canterbury Road Trauma Awards. The New Zealand Road Safety, Emergency Response and Healthcare Awards are founded by the Road Traffic Accident Trauma Charitable Trust trading as National Road Trauma Centre.

## **NATIONAL AWARD FOR COMMUNITY SERVICE**

The National Award for Community Service recognises members of the community who have provided outstanding care or support to a road trauma victim by making an influential difference to their treatment, recovery or rehabilitation.

This Award is open to members of the general public who do not meet the criteria for the National Emergency Response and Healthcare Award.



The National Award for Community Service may be Awarded for:

- Making an influential difference, contribution or assistance at the scene of a road crash, such as acts of notable courage such as rendering life saving first aid or life saving site logistics or the minimisation to serious injury and harm.
- Providing excellent service or care at the community level and offering outstanding support within primary Healthcare, post trauma or personal Healthcare.
- Community service directed towards the rehabilitation of those directly impacted by road trauma based on personal (or professional) capacity.

Each Award recipient receives a medallion and a certificate for their meritorious efforts.

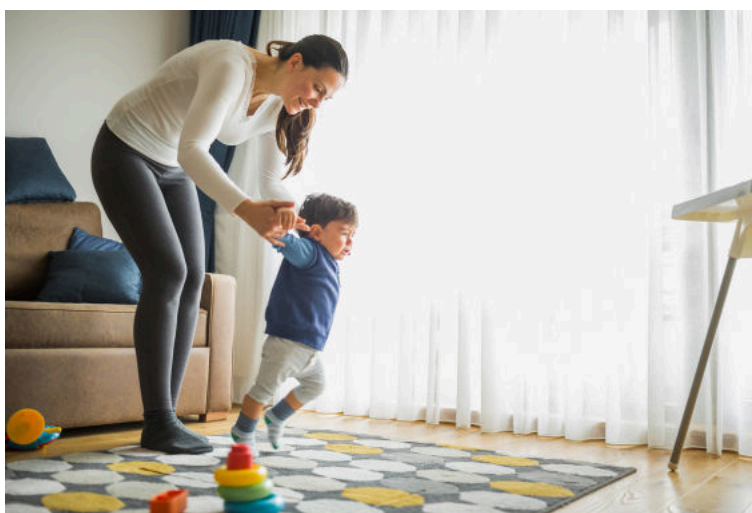


## AWARD ENTRY GUIDANCE

In preparing an application, the Committee requires a detailed account of the Applicant's contribution, particularly addressing how their service could be considered extraordinary.

- To prepare your entry submission, please ensure you have referred to the New Zealand Road Safety, Emergency Response and Healthcare Awards Criteria, Nomination and Evaluation Process.
- Complete all contact details at the beginning of the Application Form.
- Complete Assessment Criteria Section 1 or 2 (whichever applicable) and note that a 1,000 word limit in total applies.
- Links to multimedia may also be included in the submission or submission attachments.
- Letters of support for the National Award for Community Service are **compulsory**. For further information or guidance, please review the Frequently Asked Questions Guide or please contact the Awards Secretariat for further guidance.
- Submissions for the 2025 Awards will be accepted from **9.00am, 1 June 2025 until 11:59pm on 31 January 2026**.
- Please note, due to the timeframes permitted to review nominations, no late submissions will be accepted.

In some circumstances a group of persons may have been involved in a single incident. When nominating multiple people we require the details of each individual involved. The New Zealand Road Safety, Emergency Response and Healthcare Awards have an agreement with the New Zealand Honours Unit, Cabinet Office, that any significant or deserving nomination deemed by the Committee to meet the criteria for recognition by the New Zealand Royal Honours System, including the New Zealand Government Bravery Awards, the Applicant will be notified by the Committee by way of letter.

The formal decision to proceed with an Award nomination or withdraw the application, to instead nominate for a New Zealand Royal Honour, will be made by the applicant.

### **CONFIDENTIALITY**

Upon receipt, applications are collated and prepared by the New Zealand Road Safety Emergency Response and Healthcare Awards Secretariat for presentation to the Executive Committee.

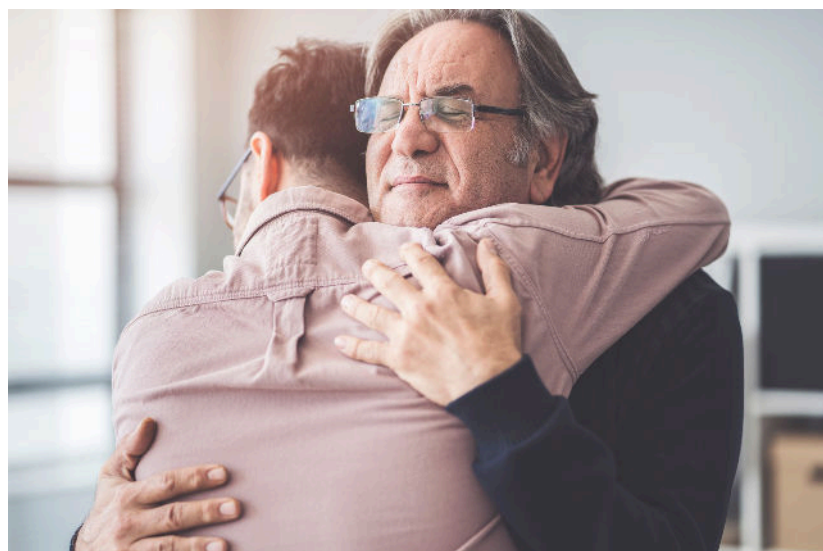

Your application will need to demonstrate how the nominee improved outcomes to reduce road trauma either at a road crash site or its direct impacts at a community level either locally, regionally or nationally in New Zealand.

To be competitive your application must address each of the following criteria and provide evidence that substantiates its claims. The criteria used to assess and judge the submissions to all situations. For each project, the New Zealand Road Safety, Emergency Response and Healthcare Awards Executive Committee will focus on the following criteria:

Particularly noteworthy response to an incidence, or incidences, of road trauma at a community level.
